

## MiniComi 2022 Release of Liability Waiver

**This RELEASE of Liability is a Legal Contract binding upon You, the Vancouver Society for the Creation of Independent Art (VSCIA), and any and all of these companies', federations' or organizations' associates, officials, employees and staff related to the event named above.**

**You verify and confirm all of the below statements by the act of paying for your table.**

I, the releaser and representative of all associates at my table, acknowledge and state that I have ACCEPTED to participate in MiniComi on Saturday, July 9th, 2022.

I hereby consent and agree to completely accept alone any and all risks of theft, loss, harm, damage or injury to the person including death, property, business or profits, whether caused by negligence, intentional act, accident, or otherwise.

I agree that I fully and forever release and discharge the Organizer and Facility, individually and collectively, and their present and former officers, directors, shareholders, employees, volunteers, contractors, agents, representatives, and attorneys, and their respective predecessors, assignees, lessees and successors in interest, from all claims, actions, causes of action, demands, cross-claims, counterclaims, obligations, contracts, indemnities, contributions, suits, debts, sums, accounts, controversies, rights, damages, costs, attorneys' fees, expenses, consequential damages, torts, losses and liabilities whatsoever in law or in equity, which may accrue individually, collectively or otherwise in connection with, relating to or arising out of my participation and/or attendance at MiniComi.

Under no circumstances shall the Organizer or the Facility be liable for any lost profits or any incidental, special, indirect, punitive or consequential damages whatsoever for any acts or omissions, whether or not warned of the possibility of any such lost profits or damages. Under no circumstances shall the Organizer's maximum liability ever exceed the amount actually paid to the Organizer by me for table space rental pursuant to this Contract. The Organizer makes no representations or warranties, express or implied, regarding the number of persons who will attend MiniComi or regarding any other matters.

I acknowledge that I shall abide by and observe all federal, provincial and local laws, codes, ordinances, rules and regulations, and all rules and regulations of the Facility including, but not limited to, any union labour work rules.

I understand that I may not display material depicting nudity or sexual conduct unless it is covered or displayed in such a way that minors cannot view explicit material, and that display content (such as images and signage) must not be derogatory in nature (i.e. racist, sexist, homophobic, or otherwise offensive to the general public).

I understand that this waiver is considered agreed to and signed once payment has been received by MiniComi, and that I will be required to have a signed copy of this waiver on file with VSCIA before opening my table to the public on the day of MiniComi.
